 4. The bidder should have a total turnover for at least three years of Rs. 50.00 lakhs for Furniture Items and sum of Rs.25.00 lacs (Minimum) for (1) Sports Items (2) Misc. Items, tenderer should have turnover of Rs.15.00 lakhs (minimum) for (3) Drawing and Cultural Items and (4) Laboratory Equipments in each of every last three financial years in purchase of Educational materials/equipments.
