Contractors who fulfill the Minimum Pre-Qualification requirement shall be eligible to apply:-

- 1) Contractor should be Registered with CPWD/Telecommunications/ MES/Railway/State Development/ Municipal Corporation and State PWD under appropriate class.
- 2) The Tenderers should have an experience of having completed such nature of works during the last 7 years ending on 30/06/2014.
 - (i) Three similar completed works Costing not less than the amount equal to **40%** of Estimated cost put to tender i.e. **Rs. 57.18 lacs OR**
 - (ii) Two similar completed works, costing not less than the amount equal to **50%** of Estimated cost put to tender i.e. **Rs.71.48 lacs OR**
 - (iii) One similar completed work of value not less than **80%** of estimated cost i.e. **Rs. 114 Lacs.**
- 3) **One work of any nature (either part of (i) or a separate one) costing not less than the amount equal to 40% of the estimated cost put to tender i.e. Rs. 57.18 lacs with some Central/State Government Organization/Central Autonomous Body/Central Public Sector undertaking.** Similar work means housing projects having brickwork, RCC, Pre-cast components roofing and allied development & electrical works etc.
- 4) **Turnover:** - Average annual financial turnover on construction work should be at least **100%** of the estimated cost during the immediate last 3 consecutive financial years.
- 5) **Solvency Certificate:** - The contractor should have a solvency of the amount equal to **40%** of the estimated cost of work.
