- 1) (a) Contractor should be Registered with CPWD/Telecommunications/MES/Railways/State Development Authorities/Municipal Corporation/State PWD under appropriate class.
- 2) The Tenderers should have completed the works as below during the last 7 years ending on 30/06/2014(cost of work shall be brought at current level by enhancing the value @7% per annum simple interest).
 - (i) Three similar completed works Costing not less than the amount equal to **40%** of Estimated cost put to tender i.e. **Rs. 40.44 lakhs OR**
 - (ii) Two similar completed works, costing not less than the amount equal to **50%** of Estimated cost put to tender i.e. **Rs.50.55 lakhs OR**
 - (iii) One similar completed work of value not less than **80%** of estimated cost i.e. 80.88 lakhs.
- 3) **One work of any nature (either part of (i) or a separate one) costing not less than the amount equal to 40% of the estimated cost put to tender i.e.Rs. 40.44 lakhs crores should have been executed with some Central/State Government Organization/Central Autonomous Body/Central Public Sector undertaking.**
- 4) Similar work means buildings Work.
