1. Minimum Eligibility Criteria:

For eligibility the bidder shall fulfill following criteria-

- I. Only one bid per bidder is permitted.
- II. Individuals, proprietary firms, firms in partnership or limited companies / corporations are eligible for bidding. **Joint Ventures will not be permitted.**

1. Minimum Qualification Criteria:

Average Turnover: The applicant firm should have an average annual financial turnover of not less than **Rs. 1 Crore** from the Consultancy services rendered by them during the immediate last three consecutive financial years.

2. Experience of Similar Works:

The consultant should have experience of rendering consultancy service in own name & should have satisfactorily completed any of the following: (The consultancy of “**similar works**” from concept to commissioning during the last 7 years ending 31st December 2014)

(a) Three similar completed works costing not less than the amount equal to Rs.2.90 Crores for each work.

OR

(b) Two similar completed works costing not less than the amount equal to Rs.4.30 Crores for each work.

OR

(a) One similar completed works costing not less than the amount equal to Rs.5.80 Crores.

and

(b) **One Completed work of any nature costing not less than the amount equal to 2.90 crore with some Central Government Department/State Government Department/Central/State Autonomous Body/Central/State Public Sector**

**Similar work means “Protection wall/Jetty work/ Port/Harbour work/wharf/bridge”*

Cost of similar completed work (is not consultancy fees) i.e. cost of construction work of similar nature.

If any clarifications are required, regarding the bidding document the same can be obtained from the Executive Engineer, OI DC Daman, on any working day or during pre-bid in written.

Other details can be seen in the bidding documents.

All necessary documents shall be submitted online and in hard copy.
