Executive Engineer, OIDC Ltd., invites item rate **e- tendering** in two bid system on behalf of OIDC Ltd., for the work of "Providing and placing Pre-fabricated Porta cabins (changing rooms) at various beaches in Daman" from eligible contractors/ construction agencies registered under appropriate class with CPWD/ State PWD/ MES /RAILWAYS and who have carried out similar nature of works and meeting the minimum Pre-qualification criteria, E-Tender is available on website <https://www.nprocure.com>

1. Minimum Eligibility Criteria:

- I. Only one bid per bidder is permitted.
- II. No Joint venture/Consortium permitted for bidding.

2. Minimum Qualification Criteria:

Turn Over: To qualify for award of the contract, each bidder should have achieved an average annual financial turnover from civil construction works of at least 100% of the estimated cost in the last 3 years ending 31st March 2015.

3. Experience of Similar Works:

The Bidder should have satisfactorily completed similar works during last 7 (Seven) years ending previous day of last date of submission of tender.

- a) Three similar works costing equal to 40% of the estimated cost. OR
- b) Two similar works costing equal to 60% of the estimated cost. OR
- c) One similar works costing equal to 80% of the estimated cost.

And

- d) One completed work of any nature (either above work or a separate one) costing not less than

40% of estimated cost with central government Department / state government department / central autonomous body / central public sector undertaking

The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of application for tender.

At the time of purchase of tender, the tenderer shall have to furnish an affidavit as under:-

“I/ We undertake and confirm that eligible similar works has / have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to notice of Department, then I/we shall be barred for tendering in OI DC/CPWD contracts in future forever. Also, if such a violation comes to the notice of Department before date start of work, the Engineer-in-charge shall be free to forfeit the entire amount of Earnest Money Deposit/ Performance Guarantee.”

“Similar work means providing and placing of modular building systems of Porta Cabins / portable cabin / MS container cabin and civil works during last seven years”

4. Bidder should not have incurred any loss in more than two years during the last five years ending 31st March 2015 (i.e. up to 31st March of previous financial year).
5. Solvency of the amount equal to 40% of the estimated cost of the work is required to be provided by the bidder.
6. If any clarifications are required, regarding the bidding document the same can be obtained from the Executive Engineer, OI DC Daman, on any working day or during pre-bid in written.
7. Other details can be seen in the bidding documents.
8. All necessary documents shall be submitted online and in hard copy.
9. Conditional bid will not be accepted.

OI DC reserves the right to reject any or all tenders without assigning any reason and the selection shall be at the absolute discretion of the Corporation and Corporation's decision in this respect shall be final and binding.
