2) The Tenderers should have an experience of having completed similar nature of works during the last 7 years ending March, 2017.

a) Three similar completed works costing not less than the amount equal to **40%** of Estimated cost put to tender **OR** Two similar completed works, costing not less than the amount equal to **60%** of Estimated cost put to tender **OR** One similar completed work of aggregate cost not less than amount equal to **80%** of estimated cost.

Similar work means "**Fencing work with barbed wire/ fencing with precast concrete planks/ construction of compound wall etc during last seven years**".

Tender Fees to be submitted along with application in the form of demand draft in favour of Executive Engineer, OI DC Ltd., Daman. The Earnest Money in the form of fixed deposit receipt valid for a period of six months or more from any schedule bank drawn in favour of the Executive Engineer, OI DC, Daman should be furnished at the time of submission of tender document. The Tender without EMD will not consider for the competition.
